

Training was a key component of the 2019-2022 collective agreement and remains an ongoing priority for the Local. Training does not happen by accident. Your union negotiated these provisions because there was a lack of employer training.

Provincial Bargaining Update

Thank you to all members who completed a Provincial Bargaining Survey by the deadline of December 17, 2021. Your contribution will assist the Provincial Bargaining Committee ("PBC") in developing proposals that will be taken to the bargaining table with the province, scheduled to commence in early February 2022.

Local 963 Business Manager Tim De Vivo will be one of two "Other Support Staff Unions" representatives on the committee, along with 18 CUPE presidents from across the province. Brother De Vivo has been on the Provincial Bargaining Committee for the past four rounds of provincial bargaining.

Nine days of bargaining have been scheduled with the province's representative, the BC Public School Employers' Association ("BCPSEA"), beginning in early February and ending in early March 2022. The Union side is hopeful we can reach agreement in the allotted days and will make every good faith effort to negotiate a fair and reasonable settlement for all K-12 support staff in B.C.

Local Bargaining Update

Typically, once the Provincial Framework Agreement ("PFA") has been reached, Local Bargaining can commence between individual school districts and their support staff unions. Provincial Bargaining addresses province-wide matters such as wages, benefits, while Local Bargaining addresses issues that are important to Local 963 members, including contract language that directly impacts their school district/local union.

In the new year please look for a **Local Bargaining Survey** that will be issued to every member who provides the local union with a non-VSB email address.
